

### INVESTMENT OUTLOOK

Developed market equities rose during June, driven by strong performance from the US, as high-momentum growth stocks continued to lead the index higher. European performance was weaker, as UK and Eurozone markets registered declines. Emerging markets fared better, with India, Taiwan and Korea strong performers, although China was a notable laggard. Bond market performance was generally positive, as gilt yields fell ahead of the UK general election. Portfolios remain broadly neutral equity risk, with a moderate preference for emerging market and developed ex-US equities, where valuations are considerably more attractive than in the US. We view the economy as in the late cycle phase – which equities typically do well, albeit with increased volatility – with our base case scenario being a soft landing.
