#### INVESTMENT OUTLOOK

March saw a continuation of market strength, as the MSCI All Country World Index, which covers all developed and emerging market equities, delivered a total return of 3.28% in sterling terms. The UK was a particularly strong performer, as the FTSE 100, the UK's index of large capitalisation stocks, gained 4.85% total return. Buoyant equity markets reflected warming sentiment around the global economy, as the chances of a "hard-landing" – a sharp recession as the result of efforts to bring inflation down – appeared to recede. This was also reflected in the prices of commodities, such as oil, which rose to over \$85 a barrel. Defensive assets, such as bonds and gold, also delivered positive returns; gold enjoyed a particularly strong month, as the price per ounce rose from \$2040 to \$2230, nearly a 10% increase. A key factor in this appears to be purchases by central banks, with major recent buyers including China and Turkey.
